
#### Tax This

Bryan Magee author of "Security & Cancelling Overprints

of Australia" from Victoria has sent me a previously unrecorded overprint found on the Victorian decimal revenues figures 1 & 2. Provenance coming from Victorian County Court, the exact purpose is as yet unknown. The Initials V.G.S. in a circular hand stamp are that of Vincent G Stafford a court official. Maybe you are reading this and recognise this overprint. If so, please share any info you may have. Bryan's monograph contains 350+ overprints, is self published and available at \$10.00 post paid. Please email me if you would like a copy. Figure 3 is a small sample of overprints listed in Bryan's book. Who knows, you may have an unlisted overprint but you will not know unless you slip this book into your library.

After searching for information on the head [fig4] used within the South Australian first Issue beer duty of 1894, I finally found it on UK Gothic coinage. I asked Francis Kiddle [UK] for any help with contacts in the Royal mint [UK] who in turn spoke with a coin expert Brian

Cartwright - ex SG, about the die head and was informed "The Royal Mint established branches in Australia at Sydney and Melbourne in 1871, and later at Perth for coining gold of imperial type. Copyright for any Royal portrait would have been held by the Royal Mint and any use of a coin design would have had to be cleared with the Royal Mint. The fact that the Royal Mint was present in Australia gives credence to your linkage of the design of the QV head". This being the case one can only presume the South Australian Government Printer approached the Mint for permission to copy the die Head in its 1894 beer duty issue [they appear not to be identical but similar]. All this is of course is conjecture, but it's a start. Others reading this may know more to the story, if so please let me know so I can update my files.

#### Perfins and Launceston 09

Mixed reviews from the perfin exhibitors. I can only talk for myself in that I was disappointed that my Revenue Perfin exhibit was moved by the judges away from all the other perfin exhibits [as we had a Perfin club challenge on] and judged with other revenues. Maybe the judges never saw the little holes in the stamps! Or maybe the title I chose threw them "Commercial Security Perfins of New South Wales". Tony Presgrave showed a nice exhibit of 'The State Transport Authority of South Australia Fare Validation Stamps' similar to the figure one shown in the December 'Revenue Review' the New South Wales State Transport Authority stamps of which these were all perforated. Dingle Smith showed 'Commonwealth of Australia Beer Duty Stamps 1903-1958'. This appeared to be a long run of years shown in just one frame, and Owen Ingles showed 'Tasmanian Bus Parcel Stamps'. This exhibit in particular had some scarce to very rare material in, and I think the Silver Owen received was a bit harsh. Unfortunately for the Perfins and Revenue exhibitors the APF chose to send three judges who are not known for judging either Perfins or Revenues. The show

itself was well run and all the locals were very friendly. It was nice to visit Tasmania and see green grass and all the Rhododendrons in flower.
